Scope of Services

Construction Inspection and Reporting

Sawgrass personnel will provide Construction Engineering and Inspection (CE&I) services for the development of this project. These services include daily or every other daily review of the Contractor's progress for compliance with the terms and conditions of the Contract Documents and Section 8 of the Design and Construction Standards for the City of Foley, Alabama and ALDOT. We anticipate that the need for our presence on the site will be during and base repairs and installation, utility relocations and during all paving operations. We will record the quantities of materials used, quality of construction practices and verify the Contractor's monthly invoices for payment match the services provided in accordance with the unit price contract.

Geotechnical Services

Construction Testing –Will coordinate with Geotechnical Consultant (Geo Con) for on-call services. These services will include but are not limited to the following:

- Observe undercutting and condition subgrade soils and provide recommendations for the use of onsite soils for backfill
- Compaction testing and backfill/import materials for subgrade or base grade
- Compaction testing of final subgrade
- Proctor test on subgrade- every 1000 LF or change in material
- Proof roll prior to asphalt or geogrid placement
- During asphalt placement- Geo Con will have a certified asphalt technician at the plant to sample for asphalt gradation/AC Content, Air Voids and Rice Gravity (one test per day)
- Asphalt coring with core thickness and bulk density – every 500 LF
- Field visits at the request of the project Civil Engineer
