Wayne,

Just an FYI, LaDonna is out today but she is needing to place an item on the upcoming agenda and plans to submit it tomorrow to Katy and Sue. As you know we have purchased a new train for the caboose club and it is supposed to be here in the late feb early march timeframe. Since the caboose club is keeping the old train so that they can run two trains at events, we need additional storage. We purchased a shipping container and modified it for the current train so LaDonna will be asking to purchase a second shipping container for the new train. I believe the caboose club has around \$11 or \$12k in their funds so she will be asking for up to \$6k. The container costs around \$3k, but the caboose club wants to insulate it and add some additional cover to the ends like they did with the current container.
