Nick Wilmott representing Crimson Land Development reported to Council that this property is located on East Michigan Avenue, Cypress Street and South Bay Street. This property will include 62 town homes and 140 apartments.

Crimson Land Development performed a traffic analysis because of the concerns of the traffic pattern, which the final outcome of the study was low impact traffic. This development will have three entrances and exits that are located on Cypress Street, South Bay Street and East Lawson Avenue. Council Member Dayton inquired about what did Crimson Land Development use for study factors for the traffic patterns. Mr. Wilmott reported to Council that intersections around the property were examined. Michigan and Juniper, Commercial Drive and Highway 59, Bay Street, Michigan and Cypress Street were intersections that were examined by the Engineering Firm.

Council Member Dayton asked Mr. Wilmott that since there are 260 parking spaces, how would that impact the traffic flow from the entrances and exits? Mr. Wilmott reported that with so many people working from home and that the property would be developed in phases, not all residents would be entering or exiting at the same time.

Police Chief Thurston Bullock reported to Council that Rodney Schrimphshire's of Semmes Towing, business license was revoked on May 3, 2021. The revoked license occurred due to the practices that resulted in a felony arrest in Mobile, AL. and Mr. Schrimphshire exhibited unprofessional conduct during an towing rotation and the patron claimed that there was property damage. This vehicle was towed to Freeman's in Foley. Chief Bullock reported that after these incidences Mr. Schrimphshire Business License was revoked and for several months, Mr. Schrimphshire operated Semmes Towing without a business license. Mr. Schrimphshire was issued a citation.

Chief Bullock reported to Council that Mr. Schrimphshire is serving a one year court ordered probation and the felony charge was dropped due to the arresting Mobile Police Officer is no longer employed with the City of Mobile. Chief Bullock reported that no matter the decision the Council makes, he feels

that it would not be appropriate to have Semmes Towing on the Police Towing Rotation until his court ordered probation is served.

City Administrator Mike Thompson asked Chief Bullock when was Mr. Schrimshire court ordered probation to begin. Chief Bullock replied February 2022 and the end of probation is February 2023.

The Council denied Semmes Towing business license application. There was no further discussion on this item.

Mayor Hellmich wanted to clarify the Economic Developmental Program. He

reported that Foley was designated by the Federal Government as an Opportunity Zone. The City of Foley is one of many Cities in Alabama that was submitted by Governor Ivey. This means that investors can invest in commercial and residential development. Opportunity Zones allow investors to look at an area that may be disadvantaged, the demographic of a certain area or the economics of a particular area. This Opportunity Zone is an incentive for investors for economic development in the City of Foley. Mayor Hellmich reported that he wanted to clarify this for the record.

Mayor Hellmich wanted to thank Council for moving forward on the Comfort Station at Heritage Park.

City Administrator Mike Thompson reported to Council that FEMA will support 90% instead of 75% from Hurricane Sally. FEMA is currently funding 75% and 25% is split between the City of Foley and the State of Alabama. The City of Foley has 3 outstanding projects currently. Once the State goes through its process then the City should receive its portion.
