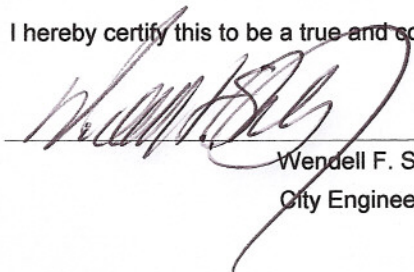

CONSENT AGENDA ITEMS

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Considers an ad in the special "Taste of Baldwin 2012" edition of the local newspapers is a useful public purpose of public funds and authorizes the expenditure of \$280.86 (TWO HUNDRED EIGHTY DOLLARS AND 86/100) dollars for one quarter page full color ad in Baldwin 2012 "A Taste of Baldwin County" edition of the Baldwin Register.

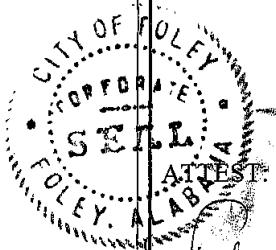
SECTION 2: Accepts a \$15,000 grant from the Schwab Charitable Fund made possible by David and Sue Vosloh for the bike path extension in Glenlakes along CR20.

SECTION 3: Memorializes the acceptance of various properties from Baldwin County Commission that they obtained through funds from a Federal financial assistance award under the Gulf of Mexico Energy Security Act of 2006 (GOMESA). The City of Foley understands the properties must be managed consistent with the purposes for which it was purchased and in accordance with all applicable laws, rules and regulations related to the GOMESA funding and shall not convert to other uses. The City of Foley further agrees to abide by the Wolf Creek Property plan as submitted by the Grantee in the form of two formal letters, which outline the development of the properties in three phases. The parcel numbers of the properties are as follows: 05-61-01-12-0-000-009.001 with an appraised value of \$351,600, 05-61-01-12-0-000-009.013 with an appraised value of \$40,000; 05-61-12-0-000-009.014 with an appraised value of \$108,000, 05-61-01-12-0-000-009.015 with an appraised value of \$22,500, and 05-61-01-12-0-000-009.016 with an appraised value of \$22,500.

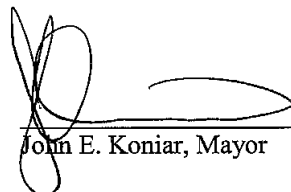
SECTION 4: Approves going to bid on the Streetscape Phase IV project.
