To Whom It May Concern:

The owners, operators, and store employees of Action Game and Movie (AGM) and The Foley Book Exchange (BE) are putting together a fundraiser for St. Jude's.

St. Jude's is a children's research hospital that is working on cures and treatments for life debilitating diseases and afflictions such as Brain Tumors, Hematological Disorders, Infectious Diseases, Leukemia, Stem Cell and Bone Marrow Transplants as well as many other childhood diseases.

The goal of AGM and BE is to raise a minimum of \$1000.00 for continued research at St. Jude's. Our plan is to put together a Zombie Run. A Zombie Run is a complex game of tag and flag football all mixed into one. To start with, there will be three (3) "zombies" and the rest will be "humans." The "humans" will each be given three (3) life ribbons. The goal is for the "zombies" to take as many life ribbons as possible from the "humans." When a "human" loses all of their life ribbons, they will no longer be a "human" and will become a "zombie." The game will continue until there is only one (1) "human" left. This person will be declared the "human" winner while the "zombie" with the most life ribbons will be declared the "zombie" winner.

Each contestant will be asked to donate \$10.00 to St. Jude's in order to play. We also hope to be able to ask some of the local business' to support our fundraiser by either donating money or by sponsoring either a "human" or a "zombie."

We are asking the City of Foley to allow us to hold our event at Heritage Park. AGM and BE are hoping to be able to use the park for a maximum of five (5) hours. The time will include an hour for setup, in anticipation of people not involved with the fundraiser as well as to protect the parks appearance, we will be setting up barriers between the game and spectators. Two (2) hours for the game itself, an hour to announce and award the winning "human" and "zombie," and an hour to clean up and take all barriers down.

AGM and BE are also asking the City of Foley to consider waiving or lowering the fees of using Heritage Park. The money that would be paid to the city could and would be used better as a donation to St. Jude's.
