Hi Jason,

Can you provide more specifics on what this invoice request is covering? I am aware of the various issues related to Local & Co and their sewer. What I am trying to verify is if these funds were used to repair or improve Riviera's infrastructure or if it was used to repair Local & Co. 's lateral and/or other sewer related issues on their property, or for both.

The Mayor indicated that he understood that Local & Co paid for the work on their private property and that the work that Riviera was doing and requesting financial support from the city for, was on your line in the city ROW.

The title of the invoice flagged it because of course the city cannot spend dollars on a private entity's repairs. Also, we cannot find where this request was ever brought to the council, so once we are clear on the use of the funds, we can bring it to council for approval.
