Fire Chief Joey Darby gave a synopsis of his report for May 2013 which is attached as back up to the minutes. He reported that he was attending a conference during June's reporting session. He also reported that the number of incidents were down in the month of May. There were two structure fires with one being outside of Foley's jurisdiction in Summerdale but Foley's Fire Department was the first responder to arrive on the scene to assist. The occupants of this structure were displaced. The other structure fire was on 6th Avenue. There were no injuries as a result of either fire. There were two wheat field fires in the month of May and he reported there was one wheat field fire in the month of June which will be in June's Fire Department Report. Chief Darby reported that these wheat fires were a result of equipment failure and each fire spread very quickly. He reported he would like to work with farmers in preventing such fires. He also reported that the Department has been very busy with public education and people from neighboring counties come to Foley for their training. He also reported that the new fire station was in the final phases with the architect.
