Police Chief David Wilson reported to Council that there are three police vehicles that the department would like to surplus due to high mileage and transmission issues. There was no further discussion on this item and it remained on the agenda.

20-0172 A Resolution to Reschedule he Council Meeting of Thursday, May 21, 2020 and Amend Resolution 19-1377 A Resolution Rescheduling Council Meeting Dates Due to Holidays and Conferences

20-0175 A Resolution Approving a Proposal For CEI On Foley Beach Express At County Road 12

City Engineer Chad Christian reported to Council that this is the final action needed for the Alabama Department of Transportation (AL DOT) to release the

funds for the project of adding turning lanes at the County Road 12 and Beach Express intersection. There was no further discussion on this item and it remained on the agenda.

20-0176 A Resolution Authorizing Residential Sanitation Write Offs as Uncollectible in the Amount of \$2,255.34

Council President Wayne Trawick asked City Administrator Mike Thompson if there was an alternative for recycling pick-up since it has been suspended until further notice. President Trawick suggested temporarily adding an extra day for trash pick-up until recycling services are reinstated. Council Member Ralph Hellmich asked Mr. Thompson if alternatively, citizens could bring excess trash to a drop off site at the Sanitation Department. Council Member Vera Quaites suggested adding an extra trash can to households upon request. Mr. Thompson reported that he and Public Works Superintendent Darrell Russell would discuss resolving this issue. There was no further discussion on this item and it remained on the agenda.

20-0177 A Resolution Approving the Surplus and Donation of Police Department Camera Equipment

Chief David Wilson reported to Council that due to the new camera system at the Police Department, there are 7 cameras that are no longer compatible with their new system. Chief Wilson reported since the cameras are good quality and in great working condition, they would like to donate them to Summerdale's Police Department. There was no further discussion on this item and it remained on the agenda.

20-0178 A Resolution Approving the Surplus and Donation of a Police Department Vehicle

Chief David Wilson Reported to Council that the Foley Police Department no longer has use for the BRINKS Truck and that they would like to donate it to Chambers County Sheriff's Office. There was no further discussion on this item and it remained on the agenda.

20-0179 A Resolution to Reappoint Orville Donald Wenzel, Jr. to the Museum Archive Advisory Board

There was no discussion on this item and it remained on the agenda.

Mayor's Comments

There were no comments to report.

Visitor's Comments

Chief Joey Darby reported to Council that he needs the media's help to clarify to the citizens of Foley the difference between 'Stay at Home' and 'Shelter in Place' terminology. The State of Alabama is under a 'Stay at Home' order, which means stay at home if at all possible. There are many exceptions on this order because people still have to live their life. If a 'Shelter in Place' order is

placed, it means stay confined in your space until it is deemed safe to go outside. 'Shelter in Place' orders are only issued in hazardous situations.

Chief David Wilson reported that if you are found outside of your shelter during a 'Shelter in Place', you can be punished by law.

Chief Darby reported that retail stores are now required by law to only allow 50% occupancy in their stores at a time. Chief Darby also reported Foley Fire Department is working with the larger retail stores making sure the emergency exits and occupancy guidelines are still being followed correctly. He reported that information regarding COVID-19 is changing daily. As of now the projected 'peak' date is April 18, 2020, which is 4 days sooner than initially projected. According to Chief Darby, this is an indication that the Social Distancing is working.
