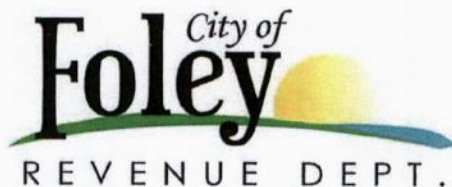

The City of Foley intends to conduct a hearing to consider revoking the Business License it previously issued to you for the above-referenced business. The reasons for the possible revocation is because of the recent arrest of owner/employee of the business for "Theft of Property 1st Degree" in Mobile County, Alabama. Other reasons for requesting revocation are for the violation of State of Alabama Act #215-470, which requires towing companies to enter vehicle information into a database and a complaint from a citizen regarding professionalism. The arrest, violation and lack of professionalism are in direct connection with the licensed business. Business licenses are issued for the privilege of being able to operate a business and also serves as protection for our citizens.

Semmes Towing and Recovery is hereby suspended from City of Foley Police Department towing rotation until the outcome of the hearing on May 3, 2021.

Pursuant to City of Foley Code Section 5-21, the violation of any municipal ordinance or a criminal law of the State of Alabama by the business is grounds for revocation of the business license. The City Council will conduct a public hearing at the Council Meeting on May 3, 2021 which commences at **4:00 PM at the City of Foley Civic Center (407 East Laurel Avenue, Foley, AL)** to hear evidence offered by you, your agent, or any other party to determine if the business license should be revoked. This letter is your notice of that hearing. If you wish to forfeit the business license in advance of the hearing, please contact me prior to May 3, 2021.
