Presentations and teaching

As a teaching pastor these 16 years of ministry my calling is to teach and instruct those who were willing to listen. At Calvary Chapel of Moreno Valley California I was the youth Pastor for 7 of those years, 3 years as a College Pastor, 2 years as the Executive Pastor, and I spent 2 years traveling to the UK, Thailand, Cambodia, and Japan teaching and instructing local pastors how to teach and instruct their people in the word of God and the basics of ministry.

Riverside Sheriff Department 2003 to 2009: I had the great privilege to be a chaplain for this Law Enforcement institution. I instructed chaptains as well as hosting seminars

on Law Enforcement family, tragedies, and understanding Law Enforcement policies and procedures.

2010 to the present for the Baldwin County Sheriff Department

I have been through much intense chaplain training over the years and now I am presently beginning to instruct other chaplains with in my department on the basics of being a chaplain. I have also been appointed the task of heading up chaplain training for all the chaplains in Baldwin County.

Foley Alabama Police Department - I am now currently instructing and leading a C.I.S.M team for the Police Chief and his department. We meet every other month for training and instruction is done by myself or the chief since we are both trained and certified.

Community Hospice of Baldwin County: 2011 to 2013

As a chaplain for this hospice care company one of my responsibilities was to train volunteers in the ministry of Hospice care work. I also went into hospitals and other medical care facilities to educate nurses and staff needing C.E.U. units (continued educational units) on the difference between a chaplain and a Pastor.

Currently a Hospice Chaplain for Asera Care: duties do include training and overseeing volunteers as well as patient care.

EMO / EMS of Baldwin County Alabama board member

I am now a active member of our county wide Emergency Management Operations of Baldwin County. In the event of a hurricane or Tornado or any kind of disaster it is my role to put in place the C.I.S.M. (Critical Incident Stress Management) teams in place requested by the municipalities in need. We are deployed by Police Chief David Wilson of Foley Alabama.

The Alabama Justice System of Baldwin County - I am now teaching a program for recovering alcoholics and drug abuse for men and women. The program is called (The Most Excellent Way).

Our local judges inquired if we could adopt this program for troubled teens in Baldwin County since there was no program for teens and our reply was yes. So now we have 20 teens going through the program.

Professional experience Disaster Relief Work **2004 Tsunami** - I was part of a team from Calvary Relief ministries who were on the ground 1 week after the tsunami hit the cost of Thailand. We were helping the people and instructing them during this disastrous event. Months later we built a resource and educational center in Phuket as we educated families through interpreters.

2005 Hurricane Katrina - I was asked to oversee all operations in Bay St. Louis Mississippi at the Calvary Relief Camp. We feed hundreds of people 3 meals a day for months. Local Law enforcement (Waveland police dept.) used our facility as a source of meals and meetings for their department. Ministries through out the United States were housed at our facility. Ministry teams would come for ten days stay at relief camp they were briefed and placed in various areas of ministry. Our relief operation camp housed the teams in tents and we had portable shower trailers for them. The teams would be instructed and trained to do the relief work which consisted of kitchen duty, mucking out houses, tree cutting, to blue tarp roofs, and then after their 10 days we would do debriefing with them before returning home. When the relief work was about to come to a close we built a church in the town of Bay St. Louis Mississippi and it remains there to this day.

Line of duty death of Baldwin County Sheriff Deputy

In November of 2012 a deputy was shot and killed in the line of duty and another was seriously wounded. I was called upon as well as our C.I.S.M. Team to come in and do debriefing with command staff of Baldwin County Sheriff Department, patrol squad of 12, EMS personal, as well as dispatchers. We were called upon to minister to the families of this tragic Incident this ministry continues today.

In April 2013 a 12 year old student commits suicide at home.

I along with my C.I.S.M. Team were called in to debrief fire department personnel, and EMS responders. A few days later we received a call from the local Elementary school and they requested our team to come in and minister to teachers and staff at the school. The principle of the Bon Secure Elementary School was very grateful and thankful for the team to come in and talk to her teachers and staff to help them cope with this horrible Incident it truly made a difference.

Honors and Awards

In 2005 Hurricane Season the Red Cross honored me with a certificate for my dedication and service in helping families that were effected by the Hurricane Katrina.

In 2009 I was Awarded a certificate of honor and appreciation for my dedication and work with the Family Justice Court in Riverside California. I was the Chaplain for the family drug court and ministered to the families that were in the program some had there children taken away by the courts and they had to do the 1 year program to get them back. And as their chaplain the families would come to me for support.

In 2013 I was awarded by the U.S. Department of Justice Federal Bureau of Investigation.

In recognition of outstanding service to the local community and of enduring contributions to the advancement of justice, received **The Director's Community Leadership Award**
