City Engineer Chad Christian reported he would happy to answer any questions about the project updates. The Project Status Report is attached as back up to the minutes.

Mr. Thompson asked Mr. Christian to give a report on the repaving project and the Tiger Grant project. Mr. Christian reported that Phase V of the repaving project is complete. They are waiting on the final invoice to see where the numbers come in. He also reported that the ALDOT permit for the pedestrian bridge will be the biggest issue for the Tiger Grant project. He believes they can expedite it forward because the consultant has former state employees that are familiar with the process and have connections with people in the Bridge Bureau. Volkert has given them a preview of the bridge's towers and foundation. As soon as the cut sheets from the bridge manufacturer are received, they will be sent to ALDOT for review by the Bridge Bureau. The hope is that the same person who had the advanced look will be looking at the total permit.

Councilman Hellmich reported that Tiger Phase I had equipment issues on side cuts, which appears to be resolved and that Phase is finishing up. Mr. Christian reported they have to do striping once the weather permits, they will then see the savings. They know it will be under budget but they do not know how much of a savings there will be at this point. There were issues on Pine Street, they had to go back and block the gutters in and that will cut into the savings but it will be more than enough to leverage into Phase II and to hopefully add one or two of the alternates.

Fire Chief Joey Darby gave a synopsis of the Monthly Fire Department Report for June, 2015, which is attached as backup to the minutes. He also reported there were five structure fires. There was a mattress fire in a bedroom on Silcox Lane, which is still under investigation. There was an electrical fire in a wall on Angie Drive, which was extinguished quickly. No residents were displaced as a result of these fires. The Department was called for assistance with a fire on the Baldwin Beach Express by the Summerdale Fire Department but was disregarded due to the fire being under control.

## **Mayor's Comments**

Mayor Koniar reported that he wanted to reiterate his comments from the Work Session that the City is still working on the downtown revitalization.

#### **Visitor's Comments**

A new resident of Foley, Bill Swanson asked what CDD means. Councilman Hellmich reported that CDD is the City's Community Development Department. Mr. Swanson asked what Tiger is. Mr. Thompson reported that Tiger is a federal grant program that the City went after to have alternative transportation, which is Transportation Investment Generating Economic Recovery. The City is using the funds for bike trails, sidewalks and pedestrian paths. The City of Foley was the smallest city to be awarded the grant. The City's staff worked hard to get the grant.

Gregg Knight, 809 E. Azalea Avenue addressed the Council with a concern on behalf of the USPS. He reported the mail carrier has driven a rut in the area between his mailbox and the street and it needs to be repaired. Councilman Hellmich reported that Mr. Knight can contact the City's Public Works Department and they will bring a load of dirt to fix the rut.

Raymond Pettibone, an Aaronville resident, addressed the Council with a request of a walkway/bridge from the church located at 323 W. Michigan Ave. to cross the ditch in order to easily access the new sidewalks across the street on Michigan Avenue. Councilman Hellmich reported the City has been looking ar constructing a pedestrian path there. Police Captain David White reported that he believed that the Police Chief is currently working with the Public Works Department to have a temporary solution in place. City Engineer Chad Christian reported his Department is currently working on a design proposal to

bring to Council soon.

Delbra Clemon addressed the Council with a concern in the same area of the church. She reported that since the street in front of the church has been repaired, she is concerned that rain water will now flood the church parking lot. She reported the repairs have made the parking lot like a bowl and water will not have a place to run off.

#### **Executive Session**

President Trawick reported there was a need to go into an Executive Session.

City Administrator Mike Thompson reported the Executive Session is to discuss what the City is willing to offer or accept when purchasing, selling, exchanging or leasing real property. There are three topics to be discussed that are informational items only and there is no need for Council to vote. The Executive Session will take approximately 30 minutes. Councilman Hellmich made a motion to go into Executive Session and Councilman Blackwell seconded the motion. Mr. Thompson took the following roll call vote: Council Member Quaites, aye; Council Member Hellmich, aye; President Trawick, aye; Council Member Blackwell, aye and Council Member Ebert III, aye. The vote was unanimous to go into Executive Session. The Council meeting recessed at 6:12 p.m.

#### Reconvened

President Trawick called the meeting to order at 7:19 p.m. All Council Members were present. Also present: City Administrator Mike Thompson and Jeff Rouzie. At this point President Trawick announced there was no further business to conduct.

## **Adjourn**

Hearing no further comments, Council Member Ralph Hellmich made a motion to adjourn the meeting. The motion was seconded by Council Member Charles Ebert III. The vote passed unanimously and the meeting adjourned at 7:20 p.m.
