Convert a vacant Building Inspector position (grade 150) to a new position of Building Plans Examiner (grade 180). This new role would improve the quality of plan reviews, provide consistency in communication with contractors and property owners, and ensure properly marked-up and approved construction plans. Convert the vacant Chief Building Inspector position (grade 180) to a Building Official (grade 250). This would remove the building official role from the current City Planner/Building Official position and create a full-time dedicated role solely to the Building division's functions and amend the position of City Planner/Building Official to Planning Director. These requests are budget neutral for this fiscal year with the two vacancies.
