WHEREAS, Country Ford (located in Southhaven, MS) submitted the lowest bid in the amount of \$27,665.41 per vehicle, the delivery time for the vehicles is up to 75 days, and the vehicles bid were a V-6 instead of a V-8, and

WHEREAS, Capital Chevrolet, an Alabama vendor, submitted a bid in the amount of \$27,733.76 per vehicle, a difference of \$68.35 per vehicle, can deliver the vehicles within 10 days, and met all specifications.

WHEREAS, the Code of Alabama, provides that in the purchase of personal property, the awarding authority shall give a preference to commodities sold by Alabama persons, firms, or corporations.

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley, Alabama, as follows:

SECTION 1: Accepts Capital Chevrolet's bid in the amount of \$27,733.76 per vehicle for a total of \$138,668.80 for five vehicles.

SECTION 2: Approves paying \$10,668.80 from restricted cash held in the Drug Asset Forfeiture Checking Account (current balance \$11,482) and increasing the budget for account 01-608-7010 for the difference in the budgeted amount and actual cost of the vehicles.
