Mr. Mike Thompson reported the Board needed to go into Executive Session to consider the sale or transfer of property. He anticipates the Board coming back out of the Executive Session for the Board to consider a vote. The Executive Session should take approximately 20 minutes.

Mr. Burkle made a motion to go into Executive Session and Mr. Rauch seconded the motion. Mrs. Southern took the following roll call vote: Chairman Ebert, aye; Mr. Hellmich, aye; Mr. Burkle, aye; Mr. Rauch, aye; Mrs. Quaites, aye; and Mr. Blackwell, aye. There was a unanimous vote to go into Executive Session.

Chairman Ebert reminded the Board that only the topic at hand may be discussed and not to venture off on another topic. The Board recessed at 3:05 p.m.

The Board Meeting reconvened at 3:45 p.m. with all board members present with the exception of Mr. Abrams. Others present Vickey Southern, Mike Thompson and Jeff Rouzie.

A resolution authorizing and approving the transfer of property based upon the restrictions inclusive of the first position on the property, which is limited to a first class sit down family style restaurant serving a variety of foods commensurate with the Purchaser's current Wolf Bay restaurant operations and to sell apparel in the gift store relating to the restaurant's business and trade name and for no other purpose was unanimously passed on motion by Mr. Rauch and seconded by Mr. Hellmich.

Mr. Thompson reported that these have to be advertised and public hearings and they anticipate it will be on the March 15th meeting before Council takes any action. The PFCD will have to decide on the User Fee and they don't know for sure if they will ask the Board to consider the fee. Mr. Heyward Hosch is looking into it. If the City is taking the responsibility of maintaining the parking area that is not just for Wolf Bay but also for the Farmer's Market, Moe's and Foreland Farms and whatever else goes in it would be nice to have a portion of a user fee to go towards the maintenance of the parking area. Ms. Steigerwald reiterated that a tax attorney is looking behind them to ensure that it is allowed.
