Mayor's Comments

Mayor Hellmich reported the City will hold a ribbon cutting for the opening of Pecan Street at 9:00 a.m. on Friday, February 9, 2024.

He reported that the City of Foley will help with presenting a plaque in partnership with the Traveling Vietnam War Memorial Fund and a ceremony will be held in Robertsedale in May, 2024.

He also reported that there is construction currently being done at Mel Roberts Park replacing lights.

Mayor Hellmich reported that a good friend and one time realtor to the City Skip Davis is ill and asked all to keep him and his family in their prayers.

Visitor Comments

Dennis Kriegh, who resides at 2651 S Juniper, Unit 1500, Foley, AL 36535, addressed the Council with concerns of some infrastructure issues around the City.

Mayor Hellmich reported that the County will begin construction this year on lighting the intersection and will install turn lanes at Co. Rd. 12 and Co. Rd. 65.

The Mayor reported that the County has the project under design for the intersection at Michigan Ave. and Co. Rd. 65 and will begin FY 2025.

Mayor Hellmich also reported that at Michigan and Hickory intersection, the design is complete and construction on the intersection will also start FY 2025 to install signals and dedicated left turn lanes with arrows.

The Mayor reported that at Co. Rd. 12 and Hwy. 59, a grant was applied for two years ago and ALDOT has approved to let the project go to bid in April 2024.

He reported that at the intersection of Co. Rd. 98 and Hickory, a traffic count has been done by the City and concluded that, the City was not ready to apply for upgrades on it at this time.

He also reported that on the Foley Beach Express an extended dedicated right turn lane going West is being installed along with safety shoulders and repaving.

Mayor Hellmich reported that the Juniper Street project has been slow due to supply chain and engineering issues. He further explained that the East end of Juniper is complete and only waiting on signals and once installed it should open back up.

Mr. Kriegh asked about the progress of the pickleball courts being installed at Wolf Bay. Ricky Rider reported that they are in the process on laying the rock down on the roads and once rains clear they will complete the project.

Executive Session

City Administrator Mike Thompson reported that there is a need to go into Executive Session to discuss certain aspects of a possible real estate transaction to discuss the consideration that Council would be willing to pay to purchase certain real property. He further reported this discussion should take approximately twenty minutes and there will be no need for Council to take vote.
