City Administrator Mike Thompson reported that the month of March had good sales tax revenue which was up 4.82% that is a good sign since the previous month was down due to the three days in January when most businesses were closed due to the icy weather. Lodging tax revenue was up 98% which is nearly up 100% from last year. The rental tax was up 9.4% from last year.

Fire Chief Joey Darby gave a synopsis of the Fire Department Report, which is attached as back to the minutes. The Fire Department responded to three structure fires, one of which was a request for assistance from the Town of Elberta for a fire in a commercial building in Downtown Elberta. Another fire was in a mobile home on Barin Field Road. Fortunately, the fire was quickly extinguished in the kitchen and did not displace the residence. There was another mobile home fire in the Brewer Mobile Home Park on County Road 26. It was a significant fire and did displace the residence. The investigation into the fire was turned over to the Baldwin County Sheriffs Office and an arrest has been made. Chief Darby reported that the Department responded to only three grass/brush fires due to the significant amounts of rain. The Department responded to 16 grass/brush fires during the month of March in 2013. There is a little over a week left until the ADEM burn ban takes effect. He also reported that there will be a controlled burn at the Foley Sports Plex on Wednesday and Thursday, April 23 and 24, 2014. Council member Vera Quaites asked if the CPR classes were open to the public and Chief Darby answered that they are open to the public; however, there is a waiting list to attend them. He reported that the Department will also go out into the community and hold classes at businesses.

### **Mayor's Comments**

Mayor Koniar reported that the outdoor classroom opened at Graham Creek Preserve. This classroom was made possible through grants. There were volunteers from Genesis Baptist Church and the Eagle Scouts that reduced the the cost of the project as well.

Mayor Koniar also reported that Foley was recognized as the 3rd best business environment in the State of Alabama and there were two other cities from Baldwin County that also made the top ten. Baldwin County is aggressive in moving in the right direction. This is based on business environment, quality of life and transportation. Foley has done quite well.

### **Visitor's Comments**

Pastor Alicia Odom addressed the Council with her concerns about the restrictions of using the Ginwright Center in Aaronville. She reported that she was told that she could not teach the youth about Jesus at the Center and that she has tried to speak with Cindy Hammrick about the issue to see exactly what she can and can not do at the Center. Council President Trawick advised Ms. Odom that the City of Foley does not have the authority over the Ginwright Center and she will have to contact the Housing Authority. Council member Ralph Hellmich reported that HUD oversees the regulations for the Center and suggested that she continue to work with Cindy Hammrick. Council member Vera Quaites suggested that she go to a Housing Authority Board Meeting. Council member Charles Ebert III asked City Administrator Mike Thompson to contact Cindy Hammrick and let her know that this was brought to Council's attention. Mr. Thompson reported he would happy to contact Cindy Hammrick. Council member Charles Ebert III also stated that he would like for Council to receive feedback from the Housing Authority on this process. He also asked Ms. Odom to leave her contact information with City Clerk Vickey Southern.

Francis Hobbs of 217 Tradewinds Court addressed the Council with a problem

she is having on her property with rain water washing trash and used tires onto her property. She reported that she needs help removing the tires from her property because the regular garbage pick up will not take them. She has tried to contact Dan Hellmich at Public Works for the past three years but she has been unable to contact him. When she finally saw him, she reported that he told her he was waiting on funding or a grant. Council President Trawick asked if the Engineering Department has been made aware of this issue. Council member Ralph Hellmich reported that there was a project through a USDA Grant that cleared some of the streams to make sure there were no back ups. He also advised Ms. Hobbs to leave her contact information with City Clerk Vickey Southern. City Administrator Mike Thompson advised Ms. Hobbs to leave her number and the Engineering Department will get in contact with her to see what can be done. He said a lot of what the City can and can not do will depend on any easements for storm water. He further advised that she and her neighbors may have to give up some space on their property for easements so the City can access their property to make some repairs but the first step will be to have the City Engineer to look at the problem. Council member Charles Ebert III suggested having Code Enforcement look into the issue as well.

## Executive Session

Council President Wayne Trawick announced the need to go into executive session to discuss the terms under which the City may be willing to offer to sell and/or purchase real property.

The real property discussion exception allows for the City to discuss in an executive session the consideration that it would be willing to offer to sell and/or purchase real property. Under this exception, only those people representing the City's interest can attend the meeting (not the party the City would be dealing with).

City Administrator Mike Thompson reported the Executive Session will take approximately 30 minutes and Council will then return to take a vote.

A motion was made by Council member Ralph Hellmich to go into executive session. The motion was seconded by Council member Rick Blackwell.

City Administrator Mike Thompson took the following Roll Call vote: Council member Vera Quaites, aye; Council member Ralph Hellmich, aye; Council President Wayne Trawick, aye; Council member Rick Blackwell, aye; and Council member Charles Ebert III, aye. There was a unanimous vote to go into executive session.

The Council meeting recessed at 6:35 P.M. to go into executive session.
