13-0423 Street and Sign Inventory Presentation.

Mr. Jay Dickson of Volkert Engineering presented a written report to the Council for City of Foley Street Evaluation Assessment and Recommendations. The report covers paved streets only and contains a total of 145 miles. Included in the report is a priority list of recommended street repairs. The priority list contains 13.20 miles at a cost of \$1,947,000. Adding a bike lane would add an additional cost of \$764,152. Volkert also performed a sign inventory and Mr. Dickson commented that the City's signs all appear to be in good shape. The primary goal of the project was to obtain a good starting point for the inventory system and all of the inventory data is now in a GIS system. Foley's Engineering Department will be trained on how to maintain the inventory so it remains a living document.
