Text of Legislative File 23-0053

A Resolution Approving Execution of a Contract for the Operation of the Farmers Market.

The FY23 budget included \$26,250 for renewal of the Market Manager contract with Alescia Forland. The contract was inadvertently not executed at renewal in October and Leisure Services is requesting approval for the Mayor to execute the contract. The "Term" (Section 5) of the contract was revised to renew annually so long as the Council appropriates funding in the annual budget. Section 9 (Termination) remained intact and allows the City to terminate the contract at any time.
