An Ordinance to amend adopted Permit Fees

Building Official Jonathan Cottis reported that Planning and Development Services has taken a comprehensive look at permit fees and how they're calculated, looking for areas that need improvement, primarily in commercial, electrical, and plumbing permits, which are entirely based on fixture counts; they propose moving to calculate those based on valuation because it will be easier for their customers. They also propose updating their minimum fees, which haven't been changed since 2011. They have aligned trade permit fees and removed deductions for multi-family. They have also added some fees for services they have been providing but didn't have a fee to charge for, such as reviewing plan revisions. They modified planning and zoning fees. They have also added administrative fees for fire permits, which the Building Department will take on the administration and intake the fire permits moving forward. They pulled all the fees from the land development ordinance into this ordinance to have all fees related to development listed on one document. He reports this will make it easier for consumers to determine what their fees will be, and also makes our fees align more with fees charged by other municipalities.

Building Officer Jonathan Cottis reported the City of Foley seeks a consultant to review and update the City's Impact Fee Program. There have been significant updates to data sources used in the previous calculations in the City's last impact fee study in 2021. Additionally, there have been several state and national impact fee court case decisions that influence how impact fees are calculated. As part of this effort, TischlerBise will provide a comprehensive evaluation of the City's current impact fee categories as well as advise the City as to whether there are other infrastructure categories the City should consider

as well. When preparing the capital improvement plan and recommended impact fee structure, TischlerBise will work with City staff to ensure assumptions and methodologies are consistent with recommended City policy directives and strategic objectives. This study will be funded with impact fee funds.

The department requests to replace the Dodge Ram with a heavy duty truck for hauling equipment around the parks. Moyer Ford provided an estimate for a 2026 F-250 Heavy Duty regular cab 4x4 at \$44,200. The replacement is not budgeted and would need the allocation of \$44,200 based on estimates. This request also includes declaring the 2020 Dodge Ram 1500 as surplus and scrap the vehicle.
