BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits
of the City of Foley in Baldwin County are altered,
rearranged, and extended to include within the corporate
limits of the city, in addition to the lands now included, all
of the following territory:

The Northeast Quarter of Section 22, Township 7
South, Range 4 East, Baldwin County, Alabama, consisting of
approximately 159.5 acres and including any existing
rights-of-way.

Tract 2 05-54-05-22-0-000-001.001

The North Half of the Southeast Quarter of Section
22, Township 7 South, Range 4 East, Baldwin County, Alabama,
consisting of approximately 80 acres and including any
existing rights-of-way.

1 Commence at the Southeast corner of Section 9,
2 Township 7 South, Range 4 East, Baldwin County, Alabama, which
3 is also the Point of Beginning; thence run North approximately
4 2,550 feet to a point on the Eastern boundary of said Section
5 9; thence run South 88° 50' 38" West approximately 2,655 feet
6 to a point on the Eastern boundary of the West Half of said
7 Section 9; thence run South approximately 2,500 feet to a
8 point which is the Southeast corner of the West Half of said
9 Section 9; thence run East approximately 2,654 feet to the
10 Point of Beginning, said tract of land containing
11 approximately 154 acres and including all existing
12 rights-of-way.

13 Section 2. In accordance with Section 11-42-6(b) of
14 the Code of Alabama 1975, a map showing what territory is
15 proposed to be annexed to the City of Foley is on file in the
16 office of the Judge of Probate in Baldwin County, Alabama, and
17 the map is open to the inspection of the public.

18 Section 3. This act shall become effective on the
19 first day of the third month following its passage and
20 approval by the Governor, or its otherwise becoming law.
