Discuss fence built by Eagle Scouts in front of the Snook Youth Club on Cedar Street parking lot.

Eagle Scout Ryan Roman showed a PowerPoint presentation regarding the need for a chain-link fence at the John Snook Youth Club along the Cedar Street parking lot. A portion of the parking lot has been converted into a basketball court. There is currently no barrier between the basketball court and Cedar Street and balls often go into the street causing children to go into the street to retrieve the balls. The Eagle Scouts are requesting permission to install approximately 120 feet of a 4ft. high chain-link fence on the west side of the parking lot to stop basketballs from going into the street. All funding for this project will be raised by the Boy Scouts and all labor will provided by the Magnolia Springs Troop 97, Boy Scouts of America. The PowerPoint presentation is attached as backup to the minutes. There was a consensus to approve the request as long as all permits from the Community Development Department are in place.

Leslie Stuckey has made a request to purchase a 50' x 130' lot owned by the City of Foley on W. Section Avenue that abuts her two lots.
