Chief,
I was informed yesterday that our two Dodge 1500 PU's that have been ordered for over two months, will not be filled. Mr. Butch Adkins, with Stivers in Prattville, told me this when I called for an update. His explanation is that they cannot fill the order due to a computer chip shortage and that they will not have any this year and possibly next year as well.

I called Donohoo Chevy in Fort Payne and spoke with Dustin Manning and he can have us two Chevy Silverado PU's just like the ones that we have purchased. He explained to me that if I want them, that he would need the PO or resolution Number by the end of next week. He further explained to me that he will not have any more vehicles before October.

If we can get this on the June 7th Council Meeting, we would need to ask for an additional \$12,000 for the two trucks and an additional \$6,000 for the equipment to put in the new trucks.
