**Engineering Project Status Report** 

City Engineer Chad Christian gave a synopsis of the Fourth Quarter 2014 Engineering Report, which is attached as backup to the Minutes.

1.) Ashford Park Drainage - They are currently looking at a western route that was suggested by one of the property owners. The surveying that has been done to the south shows that the pond and pipes were installed too deep if they go to the grades that is being dictated by the work being done by the County on County Road 20, they will not be able to drain all the water out of the pond to the bottom of the pipes. The Engineering Department will likely come back to Council to request a surveying contract to GPS to the west to Hickory Street. The controlling pipe along Hickory Street going towards County Road 20 is lower than any other pipes on County Road 20 and that is an option to fully drain the pond. Councilman Hellmich asked if the land owners were interested in it or have they suggested doing it? Mr. Christian reported that the

land owner most impacted to the south suggested the western route and the land owner most impacted to the west suggested the southern route and from an engineering stand point, they want to drain as much water as possible to reduce the snake habitat. Councilman Hellmich asked if the western land owner was receptive to this. Mr. Christian reported that until he knew it would work, he was not going to approach him again regarding it. Once a GPS survey is complete, different options can be planned out. If they take the southern route, 1 foot of water can be drained and if the take the western route, two feet of can be drained.

#### 2.) Projects:

- A.) ATRIP Phase I (Pride Drive) Mr. Christian reported that the time starts on the ATRIP Phase I Pride Drive project on January 21st and they will then have 290 days to complete the work.
- B.) Phase II (County Road 20) The work has been ongoing on ATRIP Phase II County Road 20.
- C.) Phase III (Fern Ave. Extension) Mr. Christian is meeting with ALDOT representatives on January 27, 2015 to discuss the 2 lane 4 lane cross section for the ATRIP Phase III Fern Avenue Extension project. Mr. Christian is hopeful this project will go to bid in the spring 2015 if an agreement can be reached with ALDOT.
- 3.) Dog Park Parking Lot Mr. Christian reported the dog park parking lot is now complete and they are proceeding with separating and bidding the remaining work.
- 4.) TAP Grant Foley Beach Express The plans are 98% complete for the Foley Beach TAP Grant and the right of way certification has been submitted to ALDOT. Bidding for this project will be later this month or February.
- 5.) Graham Creek Nature Preserve They are currently designing the Graham Creek Nature Preserve road extension. They have met with Environmental Manager Leslie Gahagan in the field regarding the type of culvert crossings needed to improve drainage.

He reported that he has been working with the HOA and individual property owners of Graham Creek Estates for the drainage project. He has obtained some permanent easements from individual owners. He will be sending a blanket temporary easement to one of the HOA officers to be giving to all the parties and to specific land owners of parcels that are key to the project. There are three out fall lines but there were only two on the current plan. He reported that it would be wise to upgrade the third line since it has the same issues but there are no houses beside it.

He reported the Justice Center Flume is currently underway and ahead of schedule.

The notice to proceed with the Manning alleyway drainage improvements was issued on January 5, 2015 to start the project on January 12, 2015. The contractor is currently finishing up other work. They have ordered junction boxes but have not yet received them. They should be starting the project in a week.

He reported they will be bidding the Pecan Street box culvert work in February.

They are currently working on minimizing environmental costs.

Work has been completed on the Philomene Holmes road paving.

Curbs have been put in place for the Resurfacing Phase V at the Aaronville ball park and they are cleaning the parking lot at the Cedar Street ball park. They have not placed any asphalt at this time.

Tiger Grant Phase I - Sidewalks are being installed along W. Michigan Street and pipes for the sidewalks along West Azalea Street are being installed for the Tiger Grant Phase I. project.

The Tiger Grant Phase II (shared use path) - Plans are 98% complete and the project will go out to bid in the spring of 2015.

Tiger Grant Phase III (pedestrain bridge) - The pre-bid conference will be Thursday, January 22, 2015. The bid opening will be February 5, 2015.

Mr. Christian reported he has reached a verbal agreement with the property owner to allow the placement of a UTC Wayfinding sign on his property on Highway 59.

W. Section Street drainage improvements - The pre-bid conference will be on Thursday, January 22, 2015 and the bid openings will be on January 27, 2015.

Councilman Blackwell asked about the status of the street lighting on W. Section Avenue and Highway 59. Mr. Christian reported he informed ALDOT that a street light was needed at the intersection of Highway 59 and W. Section. ALDOT has re-painted the stop bar and the divider line but they did not reply regarding the lighting. Mr. Christian reported he will contact them again about the street light.

Assistant Fire Chief Chad Brewer gave a synopsis of the December 2014 Fire Department Report, which is attached as backup to the Minutes. He reported there were three fires, one of which was a fatal fire on Monteith Oaks Drive. There was a significant fire on Bay View Drive and the third fire was extinguished by the occupant before the Department arrived on scene. He also reported that the Station 3 slab was poured on Monday, January 19, 2015, which consisted of approximately 200 yards of concrete.

City Administrator Mike Thompson reported that the year-to-date sales tax revenue is up by 6.63%. He also reported that since the Robertsdale Walmart opened last October, the Foley Walmart sales tax revenue is down 7%. He also reported that Shoe Station will be opening in March or April this year and also with the opening of Academy this spring, the sales tax revenue will continue to increase. Lodging tax revenue is up. Rental tax revenue to down 6%. A state auditor will be doing audits over the next few weeks to find the reasons for the decline because it should be going up along with the sales tax and lodging tax revenue. The decline may be due to rental companies paying to wrong cities.
