The purpose of this contract is to clearly establish the expectations, rights, and responsibilities of both Ox Foundation Solutions and you, our valued customer. Ox Foundation Solutions has earned the trust of thousands of other property owners like you because of our reliable production department and dedicated service division. Ox Foundation Solutions warranty is TRANSFERABLE by providing written notice to Ox Foundation Solutions for your coverage.

The Ox Foundation Warranty

The following applicable warranties and periods are set forth below for each specific product, Ox Foundation Solutions will stand behind and warrant our products and services, subject to and accordance to the following terms and conditions:

Foundation Piers – If you purchase and we install OX Foundation Solutions warrants that the foundation piers will stabilize the affected area(s) against further settlement for the LIFETIME of the structure in the area(s) where piers are installed.

Wall Anchors, Wall Supports, or Braces - If you purchase and we install OX Foundation Solutions warrants that the anchors, wall supports, or braces will stabilize the affected area(s) against further settlement for the LIFETIME of the structure from the date of the installation; provided that (a) Wall Anchors, Supports, or Braces are warranted solely for stabilization not straightening (b) if a wall does not have wall anchors, wall supports, or braces installed along the entire area of the wall from corner to corner, such wall will not be warranted.

Floor Supports – If you purchase and we install Ox Foundation Solutions warrants that the floor supports will stabilize the affected area(s). Additionally, the manufacturer of the floor supports warrants that they will, under normal use and service, be free from defects in material and workmanship for LIFETIME of the structure from the date of installation. If changes occur due to excess moisture in the area(s) where Floor Supports are installed, an encapsulation system, drainage, and dehumidification may be necessary in such area(s) at an additional cost to Customer.

Encapsulation System - If you purchase and we install a crawl space encapsulation system will isolate the home from the earth. The humidity level in the air will be lowered, reducing moisture needed for mold growth, however the encapsulation system does not claim to be a mold mitigation system. Wet crawl spaces require a drainage system, and a sump system to remedy the problem with water below the HealthyCrawl® liner. HealthyCrawl® has a LIFETIME of the structure warranty. Sump pumps are covered under a separate manufacturer warranty. Installation of the system does not include extending discharge lines, or electrical work unless specified.

Basement / Crawlspace Perimeter Water Control System -If you purchase and we install Ox Hydro-Guard® water control system, Ox Foundation Solutions warrants that, for a LIFETIME of the structure from the date of installation, (a) the Ox Hydro-Guard® will not clog, corrode, or decay. (b) the Ox Hydro-Guard® system controls groundwater seepage from entering into the structure where installed. Partial systems carry a limited warranty our waterproofing system only applies to where it is installed Ox Foundation Solutions strongly recommends a full perimeter system. Water that enters as a result of leaking plumbing, flooding, acts of god, and pump failure are not covered. Basement systems installed do not prevent water intrusion in the Crawl Space and Crawl Space systems do not prevent water intrusion in the basement and neither are warranted as such. Hydro-Guard is designed to be installed in conjunction with basement slabs that have a standard vapor barrier below. Sump pumps are covered under a separate manufacturers warranty. Battery Back Up Pumps are strongly recommended to protect from pump failure and/or power loss. Even with a Battery Back Up Pump we recommend a generator to protect from extended power outages. OX Foundation Solutions recommends that all drainage systems should have a wall vapor barrier installed to ensure a sealed system that will also protect from any wall leaks.

Concrete Lifting Ox Poly - On concrete over 10 years old, OX Foundation Solutions will re-pump once, in a one year period, if necessary, any areas that have resettled more than a 1/4 inch, at no cost to the customer. A re-pump constitutes using the same holes. This guarantee is void if the customer does not seal all cracks and joints on the slabs or maintain BACK-FILL along the slabs involved or if resettling occurs as a result of flooding or other acts of God. This guarantee does not include patches applied to or placed between the slabs and also does not include crack repair done by the customer or OX Foundation Solutions.

Allocation of risk. In no event shall OX Foundation Solutions be liable to client or any thirdparty for incidental or consequential damages (including, without limitation, claims for loss of business or lost profits) resulting from or arising out of the work. OX Foundation Solutions is not responsible for landscaping, damage to plumbing or electrical, cracks in slabs, floor or walls or any damage which has occurred or might occur as a result of the settling or the concrete lifting process. If the concrete cannot be raised and must be replaced, it is the homeowners responsibility to replace it at current replacement cost. 1. Although every effort will be taken during the lifting process OX Foundation Solutions is not responsible for: a. Slab cracking, sheetrock damage, any damage to existing slab finishes(Tile, Pavers, Etc) or structures located on the slab. b. OX Foundation Solutions cannot guarantee to close cracks/gaps or guarantee to level slab back to original position. 2. OX Foundation Solutions recommends the customer to have a plumbing leak test performed before the work is done. 3. Customer is responsible for removing and replacing any floor covering necessary to perform the work.

Exclusions From This Warranty - This Warranty does not cover and Contractor specifically disclaims liability for: 1)


exterior waterproofing; 2) system damage caused by Customer's negligence, misuse, abuse, or alteration; 3) dust incidental to installation; 4) damage to personal property of any type; 5) utility line breakage; 6) damage caused by mold; 7) failure or delay in performance or damage caused by acts of God (flood, fire, storm, methane gas, etc.), acts of civil or military authority, or any other cause outside of its control; 8) damage done during a lifting operation; 9) basement water seepage; 10) heave or any damages caused by it; and 11) damage caused by lateral movements and forces of hillside creep, land sliding or slumping of fill soils of deep embankments and sink holes or aquifers.

General Terms - For the applicable time periods indicated below, this Warranty is transferable to future owners of the structure on which the work specified in this Contract is completed. This Warranty is in effect if the job specified in this Contract is completed and paid in full and, alternatively, is null and void if full payment is not received. Contractor does not warrant products not mentioned above, but some of such products may be covered by a manufacturer's warranty. All material used is warranted to be as specified in this Contract. All work will be completed in a workmanlike manner according to the standard practices of the industry. Proposal is based primarily on property owners description of problem. I fully understand and accept the transferable warranty which covers only the areas the property addressed by the contractors scope of work. If the project is cancelled after nonrefundable materials are ordered there will be a 15% restocking fee. OX Foundation Solutions LLC reserves the right to cancel any existing proposal for any reason for work not performed on a project. Items For Which Customer Is Responsible - Customer is responsible for: 1) making full payment to the crew leader upon completion of the work; 2) preparing the work area for installation; 3) any finish carpentry, painting, paneling, landscaping, etc. that may be necessary after Contractor's work is finished; 4) marking any private lines such as satellite cables, propane lines, sprinkler system lines, etc.; 5) maintaining positive drainage away from the repaired wall(s); 6) keeping gutters clean and in good working order; 7) directing downspouts a sufficient distance away from the repaired wall(s); 8) maintaining proper expansion joints in concrete slabs that are adjacent to the repaired wall(s); and 9) any items mentioned in this Contract under "Customer Will" or "Additional Notes."





















































































































ACKNOWLEDGMENT AND AGREEMENT:

Except for claims by OX Foundation Solutions under Section 1 above (regarding payment of fees due to OX Foundation Solutions), all disputes and any other matter arising from or relating to this agreement (which expressly includes the interpretation, administration, and execution of all portions of this contract and all provisions contained herein) and the work performed hereunder shall be brought, heard, and resolved solely and exclusively by binding arbitration administered by the American Arbitration Association. This agreement is being signed in Alabama. The laws of the State of Alabama shall apply. The venue for such arbitration shall be Shelby County, Alabama. The single arbitrator appointed to resolve such proceedings shall have the discretion and authority to award such remedies as may be available under applicable law and to award the prevailing party costs and fees; provided, except for OX recovering fees and expenses as set forth herein that each party shall be responsible for its own legal fees.
- 3) Any alteration from the above specifications and corresponding price adjustment (if necessary) will be made only at the customer's request or approval or as set forth herein. If customer cancels the job prior to installation, the customer will be responsible for a cancellation and restocking fee equal to 15% of the total contract price.

or electronic signature, and any facsimile or electronic signature (including scanned documents in portable document format) shall be deemed an original.
