## **Public Hearing**

21-0224 A Public Hearing To Consider The Revocation Of A Business License

Council President Wayne Trawick opened the public hearing at 4:00 pm. He asked for comments from the public. Foley Police Chief Thurston Bullock reported that in Mobile County, the Satsuma Police Department had three vehicles that were seized and forfeited that were impounded by Semmes Towing and put on hold. Chief Bullock reported that the Satsuma Police reported that two out of the three impounded vehicles were missing, and that Semmes Towing had crushed them to recover costs. He reported that the owner of Semmes Towing Rodney Schrimpshire was charged with two felony counts of theft of property in the 1st degree. After further investigation, Mr. Schrimpshire had not been keeping proper records required by State Law until this incident occurred. Separately, a complaint was filed by Ms. Kayla Watson that Semmes Towing damaged her trailer jack in the towing process after an accident and when she called and spoke with Mr. Schrimpshire regarding the situation, he was unprofessional and spoke profanities at her. Chief Bullock reported that the unprofessional conduct towards citizens plus the two pending felonies show an unethical conduct and he is asking to revoke Semmes Towing's business license under these circumstances.

Rodney Schrimpshire reported that the charges against him are false and that he is not guilty. Mr. Schrimpshire stated that the vehicles were on his lot for one year and nine months and that he was not aware the Satsuma Police Department had a hold on the vehicles. He stated the lady with the complaint was informed to bring in pictures of the damaged trailer or to email them, but he never heard from her again. Mr. Schrimpshire further reported that he does not see why his license would be pulled over a complaint and two pending felony charges he has not been found guilty of.

Owner of McAdams towing Charles McAdams reported he is Mr. Schrimpshire's biggest competitor. Mr. McAdams reported that it is an easy mistake to make and that anybody could crush junk cars that they have had for over a year and a half. He also reported Mr. Schrimpshire was honest with the Satsuma Police about the matter and tried to rectify the issue by paying for the crushed vehicles but the police arrested him. He stated he sent his own attorney to assist in getting Mr. Schrimpshire out of jail. Mr. McAdams reported he believes what is being done to Rodney Schrimpshire is wrong and that revoking his

business license will leave a lot of employees without a job.

Police Chief Thurston Bullock reported that he is not aware of the type of vehicles that were crushed, or their value, but typically the police will not seize a car unless there is a significance to the car and the crime. Chief Bullock reported Mr. Schrimpshire admitted to crushing the vehicles but then argued over rights to those vehicles. The Satsuma Police Department had an impound document which Mr. Schrimpshire signed for the vehicles with the police hold on them. Mr. Schrimpshire did not try to rectify the issue until there were pending charges and jail time involved. He also stated that regarding the complaint, the issue is not whether or not the trailer was damaged, but the unprofessional conduct from the business towards the citizen.

Chris Taylor reported that he was the tow truck driver that hauled Ms. Watson's trailer and reported that no additional damages were done to the trailer.

Hearing no further comments, President Trawick closed the public hearing.

A motion was made by Council Member Charles Ebert, III, seconded by Council Member Vera Quaites, to discuss this item and vote.

Council Member Rick Blackwell asked Police Chief Thurston Bullock what will happen if Mr. Schrimpshire is not convicted of the two felonies in Mobile County. Chief Bullock reported that regardless of the criminal charges, there is still the civil issues that the Police Department is concerned about.

Council Member Vera Quaites asked Chief Bullock if Semmes Towing's business license is revoked, would they be able to apply for another one. Chief Bullock reported that if they were found innocent of the felony charges they could reapply and then it would be brought before Council to vote on. Chief Bullock also reported that the Town of Summerdale has already started this process as well due to the same infraction.

Council Member Charles Ebert, III, asked Chief Bullock if the civil complaint was emailed in or if someone from the police department had met with Ms. Watson. Council Member Ebert also asked if any of the allegations were denied by the towing company. Chief Bullock reported that she submitted her formal complaint via email and that Mr. Schrimpshire had the opportunity to speak on the allegations during the Public Hearing.

Council Member Richard Dayton asked Chief Bullock how long Mr. Schrimpshire was not keeping proper records for his business. Chief Bullock reported that Code Enforcement found that there were no entries for two years prior to Mr. Schrimpshire's arrest. He also reported that after the arrest was made, Mr. Schrimpshire started reporting to the State of Alabama as per the State's requirements for all towing companies.

Council Member Dayton asked Chief Bullock about the vehicles being on Mr. Schrimpshire's lot for the one year and nine months, who is entitled to the money made from scrapping the vehicles. Chief Bullock reported that these

particular vehicles that were crushed were part of an ongoing investigation in Mobile County and were on a police hold by the Satsuma Police Department, therefore they should not have been crushed regardless of the amount of time that they sat on the lot.

Council Member Dayton also asked if it was possible that Mr. Schrimpshire was unaware of the police hold on the vehicles. Chief Bullock reported that there was a police hold document signed by Mr. Schrimpshire for at least one of the vehicles. Rodney Schrimpshire reported that he was unaware of the police hold on the vehicles and that in the City of Satsuma, a bailiff slip is signed and then faxed to the towing company. Mr. Schrimpshire reported that he was never faxed the proper documents.

Mayor Ralph Hellmich asked Mr. Schrimpshire if he had thought about calling the City of Satsuma before crushing the vehicles. Mr. Schrimpshire reported he did not think to do that. He reported that he tried to talk to the officer about the situation but still ended up being arrested. He also reported that if there is further discussion on this situation at a later date, he would like to have his attorney present.

City Administrator Mike Thompson asked Chief Bullock if Semmes Towing has been removed from the Foley Police Department's rotation list, seeing that the business license does not have to be revoked in order to do so. Chief Bullock reported they had been removed from the Police Department's rotation of towing companies they use and Mr. Schrimpshire had already been notified of that. Chief Bullock reported that revoking the business license will stop Mr. Schrimpshire from conducting all business within the City of Foley, not just with the Police Department.

Council Member Charles Ebert, III, asked if Semmes Towing being off of the Police Department's rotation is indefinite or just until deemed fit to go back onto rotation. Chief Bullock reported Semmes Towing could be placed backed on the rotation list.

Council President Trawick reported there was a motion made by Council Member Ebert and seconded by Council Member Quaites. He asked for all those in favor of the revocation of the business license to say aye. The motion carried by a unanimously vote to revoke the business license.
