#### Foley Sports Tourism Report

Item 16-0556 was added to the Work Session Agenda.

Executive Director of Foley Sports Tourism Don Staley reported the Publix Super Cup Soccer Tournament was held over the weekend. There were 93 teams and approximately 5,000 people attended the tournament throughout the weekend. He reported the fields drained properly after the rain but the common areas did not drain as quickly. He reported the only negative issue they had was with parking but that will be corrected once the connecting roads to the fields are complete.

Economic Development Director Jeff Rouzie reported Rachel Keith has put together two separate RFPs (Request For Proposals) for concession food trailers. One of the food trailers will be obtained through the USDA Rural Business Development Grant.

Mr. Staley reported more people are seeking a healthy option to typical concession food. During last weekend's tournaments, The Red Wagon served protein bowls and wraps. There is a long list of vendors who want to be at the sports fields during events and there is up to six vendors who are interested in renting the City's food trailer.

Council Member Ebert suggested permitting the use of styrofoam containers for the vendors serving frozen products. He also recommended the drivers of the carts for the food trailers be at least 21 years of age and have a valid drivers license and the vendors to clean the areas around their respective food trailer.

Discuss the possible purchase of new trackless train for the Depot Museum

Museum Director Bonnie Donaldson reported the Charlie Ebert Training is a very popular attraction for the City of Foley and the Railroad Depot Museum. The existing train is approximately ten years old and has had to be repaired several times. It is time to get another train because the existing trains will not be in proper working order soon.

Museum- Archive Advisory Board Chairman Alton McCullough reported he along with Bob Irwin and Don Wenzel went to Andalusia Alabama to see the City's trackless train made by the Bellatori Family in Atlanta Georgia. Andalusia's train is only ran during the four weekends during Christmas holiday and during special events. Mr. McCullough also reported if a new train is purchased, they would have to have a place to store it. He also recommended using the new train and the existing train and alternating them and to use them both at the same during special events.

Mr. McCullough reported the new train will be expensive, approximately \$35,000. He reported Andalusia spent \$60,000 for their train; however, the way Andalusia paid for it was they sold advertising space on the train to local businesses. He reported the new train will have a wood body with a polymer painted shell so the drivers will have to be very careful will driving the train and storing the train.

Mr. Irwin asked Council what their thoughts are on asking local merchants about purchasing advertisements on the train to off set the costs. Mrs. Donaldson reported if having the advertisements on the train is decided the best way to obtain the new train, she would suggest having a standard advertisement that would have an antique look and so that all the advertisements would be consistent.

Council Member Ebert asked how much Andalusia sold the advertisements for. Mrs. Donaldson reported each merchant was charged the price of a train car.

Council Member Hellmich reported he believed it is a good idea to start thinking about purchasing a new train. President Trawick reported it would not hurt anything to ask the local merchants if they would be interested in

purchasing advertisements on the new train. Mrs. Donaldson reported she will make the phone calls to the merchants.

Rachel Keith reported the last train that was purchased had to go to bid because of the cost. She asked that everyone keep that in mind.

Discuss changes to the recycle day of service for certain areas

Darrell Russell reported the need to change the recycling day for certain areas of the City in order to keep the routes more simple and to prevent the drivers from covering the same areas of the City twice in one week. Marketing Director LaDonna Hinesley reported she will ensure that the residents that will be affected will have sufficient notice prior to the change.
