We need to ad an agenda item to request funds from Council to do a survey of the ditch that separates Collinwood and Meadowrun. Ralph and Taylor and I met with members of their HOA and we would like to do a survey and mark an easement so that property owners that back up to the ditch will know how much space we would need in order to Maintain the ditch. 
