Vickey/Sue,

there is something in our budget that I think we need to propose to council to modify.

Over the past few years, we have done a grant/contract for service to the Baldwin County Trailblazers in the amount of \$2,000. As you know, the Trailblazers have partnered each year with the Foley Lions Club to put on the Tour de Foley bike ride. Recently the Trailblazers President, Valery DeLaney, proposed to the Trailblazers board that they not be involved in the Tour de Foley in the future, and the board voted to end their relationship with the event.

The Foley Lions Club is going to continue the event and have reached out to the Kiwanis club as their partner. I would like to recommend that we change our budget to reflect that the \$2,000 contract for service with the Trailblazers ends (since they are no longer providing any service to our citizens), and that we instead create a contract for services for \$2,000 with the Foley Lions Club and the purpose would be to help them with the financial costs of hosting and running the annual Tour de Foley in the City of Foley.

Although I am on the Trailblazers board, I just don't see Trailblazers expanding out of the eastern shore anytime soon, and with their withdrawal from the Tour de Foley, they really are no longer involved in any programs affecting our citizens.

Although I will not be at our Oct 6 council meeting, I think we should get this corrected soon, because we would likely be initiating these payments soon after the fiscal year changes over.
