It is a \$30,000 expense to seed with rye-grass. He requested the transfers of \$15,000 from the Travel & Training Budget and \$3,000 from the Consultant/Professional Fees Budget to the Multi-Use Fields Park Maintenance Budget. The excess from travel was due to a major tourism conference being scheduled during a conflict with the staff. He stated this is an operations to operations transfer from Foley Sports Tourism 5040 accounts to the Foley Sports Tourism Multi-Fields 207 Park Maintenance Account. This action is budget neutral for FY25 but requires transfers of funds.

A motion was made by Council Member Charles Ebert, III, seconded by Council Member Richard Dayton, that this Resolution be adopted. The motion carried by an unanimous vote.
