An Ordinance ratifying the creation of and defining the operational scope of the Recreational Activities Fund.

WHEREAS, the governing body also deems it necessary to further define the operational scope of the Recreational Activities Fund to include revenues and expenditures that are a direct result of programs offered, as well as net operations of on premise concessions.

BE IT ORDAINED that the Foley City Council as follows:

Section 1. The City ratifies the creation of the Youth Sports Program adopted under Resolution 2521-05, and renamed as the Recreational Activities Fund by Resolution 2673-05, as a special revenue fund as defined by Governmental Accounting Standards Board (GASB) Statement No. 54.

Section 2. Defines the operational scope of the Recreational Activities Fund to include revenues and expenditures that are a direct result of programs offered, as well as net operations of on premise concessions.

Section 3. Pool admission, property rental, and other revenues not directly resulting from recreational programs are considered non-restricted and shall be recordable in the City's General Fund.

Section 4. All ordinances or parts of ordinances, in any manner conflicting herewith are hereby repealed.

Section 5. This ordinance shall become effective upon its publication as required by law.




ESTABLISHING CITY OF FOLEY YOUTH SPORTS PROGRAMS FUND

WHEREAS, there is a need for the City of Foley to assume financial management and accountability of the Foley Youth Sports Programs and establish a fund with a checking account in the City's name with Council member having signature authority.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Foley, Alabama as follows:


- Section 1: A checking account will be established in the City of Foley's name with Council members having signature authority.
- Section 2. Expenditures will follow normal City purchasing guidelines as outlined in the City's "Purchasing Policy and Procedures" manual adopted December 16, 2002. This shall include but not be limited to competitive bid laws, purchase order procedures and purchases made from petty cash.
- Section 3. A list of persons authorized to purchase will be established and will be added to the list of names required to complete an annual Ethics Statement.
- Section 4. Expenses are to be paid by the General Fund using the Accounts Payable process and the Youth Sports Fund will reimburse the General Fund at the end of each month.
- Section 5. Revenues shall be accompanied by detail information that ties to the deposit amount. This shall include but not be limited to registration forms, discount coupons, concession reconciliation forms, cash register tapes, etc. Persons who handle money are required to complete an annual Ethics Statement.


