Human Resources Director Suzanne Kellams reported The Sanitation Department has undergone operational changes due to rapid residential growth throughout the City. With new subdivisions and continued infill development, the Residential Sanitation Division faces an increasing workload that requires additional qualified drivers to support expanded ASL garbage and recycling routes. The department is transitioning away from rear-load trucks to automated systems for greater efficiency, and recycling routes are projected to expand to a three-truck operation, while garbage routes will grow from five trucks to six within two years. Additionally, the limb and bulk collection route requires expansion to a five-truck route to meet service demands. To support these needs, two out of five Sanitation Worker slots (grade 30) will be reclassified to two additional Residential Sanitation Driver Operator slots (grade 90).

IT Director Gary Schrader reported that the uninterruptible power supply in the server room was originally purchased around 2007-2008. The batteries were replaced in 2017 and the capacitors and fans were replaced in 2018. He stated that these are standard maintenance items to ensure the operability of the unit which keeps our servers, firewalls, and the core of our network running during a power outage and he is proposing to replace all batteries, capacitors, and fans at one time, which should extend the life of the unit approximately eight more years.

City Engineer Taylor Davis reported traffic signal upgrades were approved on the Foley Beach Express (Now SR 161) and ALDOT will be connecting the signals on SR 161 at Mifflin Rd and OWA as well as retiming the traffic signals to coordinate and synchronize the signals. ALDOT stated they could provide upgrades to the traffic signals on Mifflin Rd at the intersections of OWA, Juniper St, and Pride Blvd. He stated that Engineering would like to upgrade and modernize the three intersections on Mifflin Rd and to achieve this we would need cellular modem connectivity, controller upgrades at Mifflin Rd and Pride Blvd, a PTZ camera at Mifflin Rd and Pride Blvd, and an upgrade to the new Currux System at Mifflin Rd and OWA to match the current system at Pride Blvd and Juniper St.

Mayor's Comments

Mayor Hellmich began his report by addressing the ongoing construction at the intersection of Hickory Street and Michigan Avenue. He noted that there were no major changes to report at the moment, but confirmed the anticipated schedule for the near future. The intersection is tentatively scheduled to reopen to traffic within the next week, providing temporary relief for commuters. However, it will close again in January to allow for the completion of the remaining phases of work. The Mayor emphasized that this is a County-led project and, despite the current inconvenience, the completed intersection is expected to be a significant improvement and a "really nice intersection" for the community.

Moving on to other infrastructure projects, Mayor Hellmich provided status updates on two major road initiatives. He reported that the projects located at the intersection of County Road 12 and Highway 59, and the intersection of County Road 65 and County Road 12, are still underway. While not yet complete, the Mayor stated that significant progress is being made on both

fronts, indicating that the construction teams are moving forward steadily toward their final goals.

The Mayor then focused on the complex project involving County Road 20 and Highway 161. He informed the Council and the public that this particular effort requires ongoing collaboration between the City and the State. The primary hurdle at this stage involves coming to a formal agreement and establishing a final plan that addresses necessary design modifications and the required financial arrangements. The Mayor assured everyone that he would continue to work diligently and directly with the Alabama Department of Transportation (ALDOT) to find a mutually agreeable solution and keep the project moving forward.

In closing, Mayor Hellmich extended warm holiday wishes to the Council, staff, and the community, wishing everyone a "Merry Christmas." He concluded his remarks by officially announcing the schedule for the next official meetings, stating that the next joint Work Session and Council meeting is scheduled to be held on January 5, 2025.

Visitor Comments

Darrellyn Dunmore with Mainstreet reported that they will be holding the Christmas Fest in Downtown Foley on Thursday, December 18, 2025 from 6pm to 8pm.

The Council Meeting recessed at 5:07 pm.
