Work Session

Call to Order

Council President Wayne Trawick called the Work Session to order at 4:00 pm.

Presentation

16-0641 Presentation: Donna Watts - South Baldwin Chamber of Commerce

Donna Watts from the South Baldwin Chamber of Commerce introduced Rachel Spear, who is the Chamber's Director of events.

Ms. Watts reported the Chamber's Festival of Flavor event met their budget. The event was a success despite the fact not everyone attended who bought tickets. It is believed that may have been due to the milk truck accident on the Bay Way Bridge that had traffic stopped for most of the day.

Ms. Spear reported this year was the first year there was a qualifying event for the World Food Championships, which drew in a lot of chefs from restaurants. There were eleven chefs competing in the World Food Championships and over forty vendors and restaurants giving out samples of food. Approximately five food trucks could not make it to the event due to the accident on the Bay Way.

Randy Kurtts reported he met with residents of Graham Creek Estates several months ago regarding decorative lamp posts. There will be fifteen decorative lamp posts. The total cost for the lamp posts is \$27,000 the HOA will be responsible for \$10, 500; the City's cost will be \$17,949.20 and the annual cost to Baldwin EMC is \$1,478.40.

Chad Christian reported a Capital Project was identified as no longer being needed for the Collinwood inlets. These inlets were completed at the end of the 2015 fiscal year. There is approximately \$18,000 that can be transferred to this project to cover the City's portion of the costs.

There was a consensus to move forward with option one at those locations.

Councilmember Blackwell asked if that is the responsibility of the home owners. Mr. Davis reported there is a sign on their property but the bridge blocks the view and motorists do not see it until they are actually in the neighborhood so they requested a sign be placed on the right-of-way on Juniper Street. There was consensus to add these signs for other subdivisions in the area as needed. This item remained on the agenda.

16-0648 Resolution Amending the Pay Classification Plan for Compliance with the New Federal Final Rule to Update the Regulations Defining and Delimiting the Exemption for Executive, Administrative, and Professional Employees Which Updates the Salary Level Required for Exemption. - Sandra Pate reported this will keep the City in Compliance with new FLSA ruling that raised the salary threshold for exempt employees from \$23,2360.00 to \$47.476.00, which is effective December 1, 2016. This item remained on the agenda.

16-0650 Accept Donation of Park Bench at Graham Creek from Gulf Shores Garden Club - Leslie Gahagan introduced Kim Edgerton from the Gulf Shores Garden Club, who donated a bench to the Graham Creek Nature Preserve. The bench is valued at \$600.00. This item remained on the agenda.

Mayor Koniar also reported the Foley Library was rated number one in the nation by The Library Journal.

Sal Muccio asked what the status is on adding stop signs on Park Avenue in Ashford Park subdivision. City Engineer reported they are work on a solution and they can add a four way stop sign.
