Council President Wayne Trawick arrived at 4:05 p.m. President Pro Tempore Ebert, III turned the meeting over to President Trawick.

City Administrator Mike Thompson reported to Council that the Planning Commission is making a recommendation of a Medical Overlay District for this area. Mr. Thompson reported that this district would establish guidelines for hospitals, medical clinics, health care and related retail, hospice services,

medical staff facilities, offices for doctors and dentists and other health care providers both public and private.

Public Works Director Darrell Russell reported to Council that he has brought two options for the sidewalk project. Mr. Russell reported that this is located north of OWA Blvd and east of Pride Dr. that includes the existing four foot wide sidewalk. Mr. Russell reported that this sidewalk is not wide enough for golf cart use.

Option 1. is to excavate the existing concrete with dowels sixteen inches apart and this would add two more feet of sidewalk.

Option 2. is at a higher price point, this would include Public Works Department excavating the existing concrete and repurpose this into riprap.

Mayor Hellmich reported that street lights are along the east side of the existing sidewalk. He also reported to Council that the City of Foley and OWA have established an agreement that the additional sidewalk would be golf cart friendly. Mayor Hellmich reported that the property for the RV Park is also golf cart friendly.

Council President Wayne Trawick reported that Council needs to decide which option would be more sustainable and most cost efficient. Mayor Hellmich and President Trawick agrees with bringing this item back.

Mayor Hellmich also reported that Council should take into consideration that the section on the east side contains an environmental grant restoration.

Mayor's Comments

Mayor Ralph Hellmich reported to Council that the referendum of the Mills Community Annexation is set for voting on August 22, 2023 from 7:00 a.m. to 7:00 p.m. He also reported that the City will be placing a sign at the parcel of land that will be the future Mills Community Park. Mayor Hellmich reported that the citizens are excited to see progress in the community.

Mayor Hellmich reported that the FY2024 would include the reapplication of the tap grant for the improvement of the sidewalks. He reported that the delay on the improvements of the school crossings are due to ALDOT not approving to move forward on the bidding process.

Mayor Hellmich reported that the owners of the Cactus Cantina building have started the refurbish project of the building structure. He also reported that Portabellas has reopened and has a new chef. Mayor Hellmich reported that Downtown Foley has rejuvenated new restaurants. He also reported the facade grants are resulting in a positive progression with the revitalization of the downtown area.

Mayor Hellmich reported that the Juniper Street extension is not completed because of the signal light arm has not arrived yet. ALDOT has communicated that this essential part should be in and completed in August 2023.

Mayor Hellmich reported that the construction on the pickle ball courts is moving forward. He also reported the new Public Works Campus will start the bidding process on July 6, 2023 and the remodel of the restrooms at Heritage Park is currently working in a positive direction.

Visitor Comments

Roddy Burkle who resides at 8343 Bay View Drive reported to Council that he would like to thank Environmental Director Leslie Gahagan for attending the meeting of the Bay Forest and Graham Creek Owners Association. Mr. Burkle reported that Mrs. Gahagan gave guidance and options that are available to acquire the Downey Property that is located near Graham Creek.

John Lynch who resides on County Road 12 near Glen Lakes east of Fairway

Drive inquired about the notification to citizens of date and time changes of Council Meetings. Mayor Hellmich reported that we advertise on Facebook, and the city's website.

Mr. Lynch reported his concern with the high volume of speeding on County Road 12 and the danger that this could cause in this neighborhood. Mr. Lynch also inquired about the speed data and the results from the speed monitor study. City Administrator Mike Thompson reported that the results of the speed data for the road capacity and congestion of traffic is about 2,800 cars per hour and County Road 12 is operating at about 5% to 7%. Mr. Thompson also reported that the study showed that the average speed is about 42mph. Mr. Thompson reported that the City Engineer does not yet have the full study report.

Mayor Hellmich reported that with narrowing the lanes on the road of County Road 12 can aide in reducing the speed of vehicles. He also reported that studies have shown that the more comfortable a driver is the higher rate of the speed is driven.

Mayor Hellmich reported that the City will study the full data report. Mr. Lynch reported that he would like to see a stop sign. Mayor Hellmich reported that the City will look at other avenues for a positive result.

Executive Director of Foley Main Street Darrelyn Dunmore reported to Council that she would like to thank the Public Works Department for the outstanding work for the installation of the mural painting at Alston Street. Mrs. Dunmore invited Council on August 11, 2023 for a photo op. Mrs. Dunmore also invited Council on August 18-20 for the Main Street Conference hosted by Huntsville, Alabama and May 5, 2024 the National Main Street Conference will be hosted in Birmingham, Alabama.

Adjournment
