Review proposals and select contractor for construction of vertical structures

Mr. Mike Thompson reported during the last PASFCD meeting the board members approved the stipulated sum that delayed the vertical build to enable going to bid to see if there would be any competitive pricing than what Killian offered before moving forward. HPM solicited for bids for the vertical structures and received the bids yesterday. At this time Nick Klarman arrived and distributed the summary of the bid report. The base bids are as follows:

1) Killian \$805,280; 2) MW Rogers \$1,259,732; and 3) Highland Group \$1,175,000. The lowest responsible bid was Killian at \$805,280, which HPM recommended plus the alternates. Even with the Killian's alternate bids for the bleachers, etc. their bid is still lower than the other two base bids.

Mr. Koniar made a motion to adopt a resolution approving the issuance of the Notice to Proceed and Mr. Ebert seconded the motion. The vote passed unanimously.
