FOR THE FOLEY POLICE DEPARTMENT FROM PUBLIC SAFETY SALES

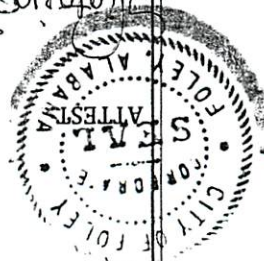
NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley,
