Public Hearing To Consider The Revocation Of A Business License

Council President Wayne Trawick opened the public hearing at 5:33 p.m. He asked for comments from the public. City Prosecutor Mike Dasinger reported Klifton Adam Bond, owner of B&R Tire Automotive was properly served with a copy of the notice of the public hearing to revoke his business license. Mr. Dasinger also reported Mr. Bond was charged with unlawful possession with intent to distribute methamphetamines as well as other drugs out of his

business and possession of drug paraphernalia which is the reason for the business license revocation.

Rick McCall, resident of Magnolia Springs reported he has been doing business with B&R Tire for eight years. He has bought tires and used B&R's mechanic services. He reported he has never seen any drug business taking place at B&R and he would like to continue doing business with this business. Mr. McCall further reported it is his understanding that it was an employee of B&R Tires that was selling the drugs, not Adam or Mandy Bond.

Lisa Clark, 5522 Lemon Tree Lane, Gulf Shores reported she personally knows Adam and Mandy Bond and they good people. She reported she has been in their house and their place of business and she has never seen any drug activity. She further reported Adam and Mandy Bond are very nice people and they are very generous and helpful to others. They made a mistake and hired the wrong person to work for them, who was selling drugs and they deserve a second chance.

Christopher Clark, 5522 Lemon Tree Lane, Gulf Shores reported he worked for B&R Tire for two years and they are a successful business and he has never seen drug activity take place at the business. If drug activity was to ever take place, the employees would have let Adam Bond know about it and he would have fired them.

Mr. Dasinger reported he would like the case agent to explain what transpired. Deputy Jeffrey Bunn reported he, along with the Foley Police Department, are on the Baldwin County Drug Task Force. He reported he received a drug complaint on Klifton Adam Bond, the owner of B&R Tires Automotive. He reported he conducted surveillance on the business and used a confidential informant, who purchased methamphetamines from Adam Bond at the business on two separate occasions. Deputy Bunn obtained a search warrant to search the business. Upon execution of the search warrant, Deputy Bunn reported contact was made with Mr. Bond and he had in his physical possession over 12 grams of methamphetamines. Photographs of the search, area and the evidence were taken and shown to Council. Donald Thomas was also arrested for drug possession at the business. There was also heroin and marijuana located at the business. A meth pipe, a spoon with drug residue and various pills were located on the desk of Mr. Bond's wife Mandy Bond at the business. Five arrests were made at the business. Mr. Bond was also out of jail on bond for a felony charge of receiving stolen property in August, 2016 and since this drug arrest, he was also arrested for DUI in Gulf Shores.

Foley Police Sergeant Steve Smith reported he hand delivered the notice of the revocation of the business license to Adam Bond and he witnessed Mr. Bond read the notice.

Hearing no further comments, President Trawick closed the public hearing.
