SCOPE OF SERVICES

Hutchinson, Moore & Rauch, LLC (HMR) shall perform the following professional services.

CEI

Lump Sum \$70,150

HMR will provide construction observation during construction to ensure adherence to the construction plans & specifications. Other services provided will include ADEM inspections, inspection reports, quantities & contractor pay requests, etc. This fee will include both the portion of the job constructed by the BOE's contractor and the portion of the job constructed under the City contract. This fee will cover 28 weeks (which includes the current allotted contract time of 168 days & 4 additional weeks).
