- Optional pay as you play Game Challenges open to public and non members

SATURDAY - 8:30AM to 11:30PM

- Must be ACO Member and pay small entry fee to ACO to compete in points earning events, all other luck of draw and game challenges open to public
- ACO Major Singles Tournament (world points earning event)
- ACO Major Doubles Tournament (world points earning event)
- Optional pay as you play Luck of the Draw open to public and non members

ACO will be the Official Tournament Organizer/Director:

ACO to provide:

- ACO will set up and tear down courts
- ACO will keep 100% of all registration dollars and game dollars

Foley Sports Tourism to provide:

- \$5,500.00 in bid fee to American Cornhole (ACO) (\$3,500.00 if paid all up front)
- Approximately 25,000 sq ft of indoor space with minimum ceiling height of 14'. This space would be provided at no cost including bleachers for center court set up, chairs, tables, bike raking to divide into zones, all fees waived as it relates to the facility, etc....
- 4 hotel rooms for 4 nights for staff (16 total room nights)
- \$400 (\$200 a day) for staff for food & beverage
- Local and regional marketing through online, print, radio and television to the best of Foley Sports Tourism ability
- Keep pricing reasonable including \$3.00 20oz beers (Bud Light, Coors Light, Miller Lite, etc....)
- Foley Sports Tourism keeps all heads and beds revenue
