Randy,

The below total is what it will cost to get power to the intersection at Fern and Juniper and install two 108w cobra head style lights for the intersection. The design plan is to install an overhead pole line along Fern near the rear of the ROW on the north side approximately as shown in the attachment. Based on this, we would need you to have the north ROW staked at about every 300ft and anywhere the ROW shifts or changes direction. We can meet onsite when the time comes and fine tune this if needed. Also, of course, the city would need to apply for said lights as well when the time comes.

Total for power and light install - \$11,103.38
