To whom it may concern;

I have submitted an application to use Foley's Heritage Park for our wedding ceremony and reception on March 14, 2015. I would like to formally request that we be allowed to serve alcohol (beer and wine only, no hard liquor) during the reception. I understand I will need to hire two police officers for the duration of the event, and rent at least three port-a-johns.

Additionally, we would also like to be granted the use of sparklers. According to the rules of the park, tea lights are allowed, but "fire" is not; sparklers are not specifically mentioned. They would be in the hands of adults only, and only during a designated portion of the reception. Please let me know if this is permissible.
