AIRPORT FRANCHISE AND LICENSE AGREEMENT Amendment 2

This Amendment relates to the Airport Franchise and License Agreement dated July 19, 2021, as previously amended by Amendment 1 dated June 21, 2022, (collectively referred to as the "Agreement") as and between the CITY OF FOLEY, an Alabama Municipal Corporation (referred to as "Owner") and Lightning Aviation, LLC (referred to as "Provider"), all of which may be collectively referred to herein as "the Parties".

WHEREAS, the Parties desire to change and extend the ending date of the Initial Term and change the duration of the Renewal Term;

NOW, THEREFORE, in consideration of the mutual rights and obligations of the Parties under the Agreement, and other good and valuable consideration, the Parties hereby agree as follows:

That Section 2 of the Agreement is hereby amended to read as follows:

2. Term. The initial term of this Agreement ("Initial Term") begins on July 19, 2021 and ends on September 30, 2034, unless sooner terminated. Under mutual agreement between the Owner and the Provider, this Agreement may be renewed under the same provisions for one additional ten (10) year renewal term ("Renewal Term") by the Provider giving notice to the Owner no more than 90 and no less than 60 days prior to the expiration date of the Initial Term, subject to Owner's agreement.

That all other terms and conditions of the Agreement, except as expressly provided herein, remain in full force and effect.
