WHEREAS, the Volkert completed the Roadway System Report – 2007, and

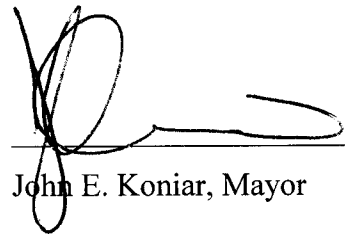
WHEREAS, the Traffic Impact Study Requirements have been completed with revisions made by the City's Engineer.

SECTION 1: Accepts Volkert's Roadway System Report – 2007 and the Traffic Impact Study Requirements with revisions.

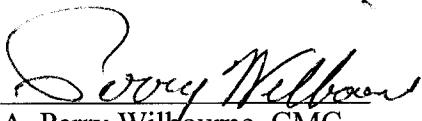
SECTION 2: This Resolution shall become effective immediately upon its adoption as required by law.

PERFORM A CITY-WIDE TRAFFIC STUDY

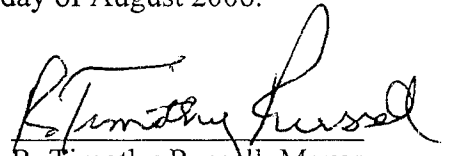
WHEREAS, the City of Foley has hired a firm to complete a comprehensive master plan,
and

WHEREAS, the City deems it necessary to have City-wide traffic study performed in
conjunction with the comprehensive master plan.

NOW THEREFORE BE IT RESOLVED that the City Council of the City of Foley,
Alabama:

- Section 1: hires Volkert & Associates, Inc. to perform a City-wide traffic study to
develop recommendations to be implemented by the City as requested.
- Section 2: adopts Volkert's Task Agreement No. 48 in the amount of \$59,500
(FIFTY NINE THOUSAND FIVE HUNDRED AND NO/100) dollars and
is made a part of this resolution upon its adoption.
- Section 3: Volkert & Associates will work in conjunction with Barge, Waggoner,
Sumner & Cannon, Inc. to ensure that the comprehensive master plan
includes infrastructure development.

TASK AGREEMENT NO. 48
THE CITY OF FOLEY, ALABAMA
STUDY OF FOLEY TRANSPORTATION SYSTEM

This Task is to be performed in accordance with the provisions of the agreement between The City of Foley, Alabama (OWNER) and **Volkert and Associates, Inc.** (ENGINEER) dated May 17, 1997.

A. SCOPE OF WORK

Generally, the scope of work includes engineering services to perform a city wide traffic study to develop recommendations to be implemented by the City. The study will include proposed new developments both residential and commercial known to the City. More specifically the work includes:

Engineering

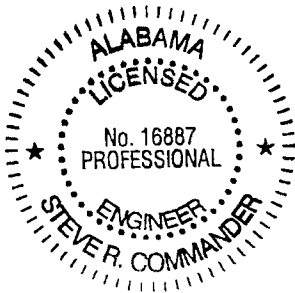
Services include:

- Coordination meetings with the City
- Develop map of current transportation system and assign functional classification
- Identify current traffic generators
- Identify locations of through trips
- Identify planned developments and develop trip estimates
- Identify locations with growth potential
- Develop future transportation network
- Review future traffic volumes
- Develop list of short term and long term improvements with potential costs
- Develop typical sections and design criteria for future roads
- Develop standard traffic impact study requirements including requirements for laneage and turn lanes
- Meet with the City
- Adjust plan based upon city input
- Finalize plan and develop report
- Present report to the City of Foley City Council
- Revise report and submit final

Lump Sum Fee: \$59,500.00

SCHEDULE - Work will be scheduled upon receipt of authorization and will continue until complete.

PAYMENT - The fee will be billed as the project progresses based on a percent completion. The total amount of fee will be due upon completion.
