There was a cooking fire at the Waffle House on Foley Beach Express that was quickly extinguished and had no damage or injuries and a cooking fire at an apartment on Azalea Avenue with no injuries or damage. He reported that the number of brush/grass fires are down due to fire prevention efforts as well as having a rainy summer. He also noted that October is Fire Prevention Month. He reported that he went to Pennsylvania to see the new fire truck that is on order and he said he is very pleased with it. The truck is now in Decatur Alabama and should be in Foley next week. Council Member Vera Quaites reported that she likes the looks of the new report for the Fire Department.
