#### Discussion Items

There were no discussion items on the Work Session.

#### Discuss Council Meeting Agenda for September 3, 2013

13-0951, 13-0952, and 13-0953 - There were problems with the advertising and the resolutions needed to be rescinded to list the correct public hearing dates.

13-0960 The transfer of funds is to set up the spare room in the HR Department to use as a small conference room. This will help with the high demand due the conference room being booked with additional meetings.

13-0966 Butch Stokes requested this item be carried over for a future meeting as he continues to work with the County on obtaining an intergovernmental agreement.

13-0970 Mike Thompson reported all the directors did a good job and put in a lot of time working on their individual budgets for the year. Sue and her staff did a great job at putting the budget together.

13-0974 Joey Darby reported he found a company that is willing to purchase the 1995 E-One Custom Fire Pumper for \$50,000 and recommended that once the new truck comes in to move forward with the disposition of the old truck.

13-0978 Mike Thompson reported this item shows a not to exceed \$2,000 amount for an appraisal of a portion of Ms. Underwood's property located on North Cedar Street. She is willing to sell five acres so that the City can expand the Sportsplex with an additional 5-plex. The appraiser has come back to the City and stated he would charge \$675 to do the appraisal.

13-0979 Mike Thompson reported there are problems with the way the resolution is worded and it will need to be worked out prior to its adoption. It must state that there is a public purpose and the conditions spelled out.

All items are to remain on the agenda with the exception of File ID 13-0966, which is to be carried over to a future date. There were no additions.
