Mike Thompson reported there would be approximately \$7,500 in closing costs that the City would need to pay. Fire Chief Joey Darby publicly thanked Mr. David Vosloh for the land donation. Resolution was retained on the Council meeting agenda. 13-0379 Discuss proposed changes to the rental procedures for the Auditorium and the Council Chambers. Pam Harris provided an overview of the proposed changes to the rental procedures. She researched ten other facilities in the process of developing the proposed changes for Foley's facilities. The new rental fee for the Chamber will be a \$50.00 base fee for the first three hours and then \$25.00 each additional hour. For the auditorium, non-profits will be able to rent the facility for ½ price and no charge for the kitchen. However, this reduced rate will be limited to one time a year. The Council requested to also add to the rental contract a clause that the City reserves the right to require proof of insurance dependent upon the nature and size of the event. The new fees will go into effect February 1, 2013 and the Municipal Complex will notify by letter all regular and pending customers. Resolution was retained on the Council meeting agenda.
