ADDENDUM TO INTERGOVERNMENTAL SERVICE AGREEMENT

This Addendum is made as of the last date written below between the City of Foley, Alabama, an Alabama municipal corporation (the "City"), and the Baldwin County Commission, a political subdivision of the State of Alabama (the "County"), regarding their respective responsibility for maintaining different portions of County Road 20.

WITNESSETH

WHEREAS, City and County are parties to an agreement dated October 8, 2013, calling for improvements to be made to County Road 20 to be paid for from ATRIP grant funds (the "Intergovernmental Service Agreement");

WHEREAS, the ATRIP grant agreement calls for the applicant, the County, to agree to maintain County Road 20 following the completion of the project; and

WHEREAS, a portion of County Road 20 is currently being maintained by the City as set forth in the Intergovernmental Service Agreement, and the Intergovernmental Service Agreement sets forth the agreements and obligations of the County and City regarding the present and future maintenance of County Road 20;

NOW THEREFORE, the City and County agree that, notwithstanding anything contained in the ATRIP grant application or agreement, the City's and the County's relative rights, responsibilities, and duties concerning the future maintenance, repair, and responsibility for the various portions of County Road 20 are as stated in the Intergovernmental Service Agreement which shall continue in full force and effect. Neither the City's nor the County's relative rights or responsibilities concerning present and future maintenance of County Road 20 are changed by the ATRIP grant agreement between the County and the State.
