Discussion Items

13-1202 Audit planning communication.

Council President Wayne Trawick announced that Kevin Lesser from Warren Averitt was present and was going to give a brief discussion about the City's audit process. Mr. Lesser thanked the Council for allowing him to come and speak on such a short notice. He reported that The American Institute of Certified Public Accountants came out with a new pronouncement that is effective for financial statements issued for periods ending after September 15, 2012 that require the auditing firm to have direct communication with those who are in charge of governments. He circulated letters to all Council members that is a condensed version of their engagement letter. The purpose of the letter is about having open communication. He advised Council that if there was anything in particular the City wants Warren Averitt to look over, to call him. Auditors started the audit process at City Hall today and he informed Council that the letter outlines that the auditors will be here for three weeks and an official audit report is expected to be issued by March 31, 2014. The letter outlines the firm's responsibilities to audit the City of Foley and issue an opinion and to obtain reasonable assurance, it is not absolute. They do not look at every transaction that takes place at the City of Foley. They use sampling techniques.

Councilman Blackwell asked Mr. Lesser if the firm is using in-house or outside auditors for the audit. Mr. lesser answered that the auditors that are working on the audit are in-house auditors.

Mr. Lesser again thanked the City.
