Mayor's Comments

Mayor Hellmich recognized and explained the Distinguished Budget Award the City received for their outstanding accountability to the budget.

He reported that the Arbor Day Tree Dedication will be held at 1:00 p.m. Saturday at the Farmer's Market.

He also reported that the Riviera Utilities Board has recently hired and named Brian Skelton as the new CEO of Riviera Utilities.

Visitor Comments

Brian Schwab, who resides at Dundee Cr. Carnoustie Gardens Subdivision addressed the Council regarding his concerns with the health and safety of the City's public swimming pools. Mayor Hellmich reported that a new and modern Aquatic Center is in the design process and looks to be in construction by next year and available for use by end of 2025 or 2026.

Mr. Schwab also inquired about the access to reports and return investments on the tax payer funds that are being used as equity in commercial development. Mayor Hellmich explained that our City does support commercial development and does not support residential development because that is not where tax payer money is generated to provide services. He further explained the commercial development is critical to the support and development to the City financially by providing 60% to 70% of the City's revenue. He also explained that the City has entered into public/private partnerships that are watched closely and run 5 to 15 years and all have generated a return on the investments.
