She also reported that to begin development of this future department, staff proposes creating the new position of Destination Marketing & Creative Services Manager to lead the development and implementation of destination marketing strategies, oversee creative content and branding initiatives, manage tourism-focused digital and print communications, analyze marketing performance, and support the City's tourism and event promotion. She further reported that this request is budget-neutral due to a budget surplus in the Marketing Department's personnel accounts, and this position and the associated personnel budget will remain in the Marketing Department for FY26 and will be transferred to the Destination & Events Services budget in FY27.

Mayor's Comments

Mayor Hellmich reported that the challenge coins commemorating America's 250th Anniversary have come in and are of high quality.

He thanked the committee tasked with reviewing the new Senior Center proposals for their time and efforts. He reported that the City is looking forward to the new facility.

He reported that many projects are nearing completion, including the First Responders Safe Room, the new Library, and the sidewalk project along Highway 59. He also reported that there are many new projects ready to begin soon, such as the comprehensive Mills sidewalk project. Mayor Hellmich reported that these sidewalk projects are part of the City's goal to improve local connectivity.

He reported that the budget is coming along well, and will reach out to Council Members individually to discuss financial strategy moving forward.

Mayor Hellmich reported updates regarding new businesses scheduled to

open soon, stating that the Half Shell Oyster House will open on June 24, 2026, and BJ's is projected to open before Labor Day.

He reported that concerns have been raised regarding potholes on private roads in the area. He explained that the City faces limited options in these cases because Public Works is prohibited from performing repairs on private property. He further reported that to address the issue, barricades might be necessary to prompt property owners to carry out the required maintenance.
