18 0302 APPROVES TEMPORARILY REDUCING SPEED LIMIT ON NORTH JUNIPER STREET

City Engineer Chad Christian reported to the Council that the contractor has now mobilized into the area and is moving with construction. Mr. Christian reported that the Police Department has placed a speed trailer in the area and signage has been placed to mark construction. Mr. Christian reported to the Council that when the construction is complete the resolution to rescind the temporary speed limit will be brought to Council.
